# you didn't challan the water: HC e probe, transfers case to CBI

Three UPSC aspirants who drowned after being trapped in the basement of a civil services coaching centre in Old Rajinder Nagar last week, a division bench of the Delhi High Court Friday ordered that the probe be transferred to the CBI.

"Mercifully, you didn't challan the water, saying 'how dare you enter the basement'....," Acting Chief Justice Manmohan remarked while clamping the

that the public has no doubt" on the probe and considering the possibility that the incident "may involve corruption by public servants".

It also directed that the probe by CBI be supervised by a senior official nominated by the Central Vigilance Commission (CVC). The official will have to ensure that the probe is completed in a time-bound manner. Additionally, the bench directed

headed by Chief Secretary of GNCTD and also comprise the MCD Commissioner, the Delhi Development Authority Vice Chairman and the Delhi Police Commissioner; it has been directed to submit a report in the next 8 weeks.

Observing that the financial health of the MCD is "precarious", the bench noted that the agency "has no funds" for "major infrastructure". In its order,

"We are senior citizens. My husband is 67 years old. Why are we being harassed," asked Nita, a retired principal of a government school in Chandigarh.

"As senior citizens, we got worried after seeing the notice. When the policemen came before the elections to check with us, they had records that mentioned my husband's name. How come the deputy commissioner's office served such a notice? The arms licence was transferred 20 years ago and has seen subsequent renewals as per procedure," Nita added.

The deputy commissioner's office has issued over 700 notices to people for non-renewal of their arms licences.

Deputy Commissioner V Pratap Singh while speaking to *The Indian Express* said that the matter has been brought to his knowledge via media. "If the contentions of the noticee were found to be correct, the notice would be duly withdrawn," he added.
